Shalajeva A.V. STUDY OF THE CONCEPTS "TERMINOLOGY" AND "TERMINOSYSTEM" AND THEIR MAIN DIFFERENCES

Each developed language has thousands of terminologies and terminological systems. The purpose and objective of the study is to identify differences between the terminology and the terminological system for a more accurate understanding of this phenomenon.

The word "terminology" comes from the word "term" and the Greek "logos", which means the word. Terminology is the science of terms. Words that are used to name various scientific and technical concepts are called terms, and a discipline that studies the properties of terms and the principles of their ordering and description is called terminology. The main objects of study in the framework of theoretical and practical terminology are sets of terms - terminology and terminological systems.

Some scholars believe that terminology is a common set of special names in various fields of science and technology, functioning in the field of professional communication. Other linguists define terminology as a spontaneously established set of terms that reflects the historical process of accumulation and comprehension of knowledge in a certain field. The terminology is replenished at the expense of common vocabulary and, in turn, enriches it. In terminology, the number of international words is greater than in other layers of vocabulary.

They are formed on the basis of Latin and Greek roots or are borrowed by peoples from each other along with the assimilation of scientific and technical concepts. However, in some languages as a result of the language policy and national traditions, the percentage of international terms is less than in other languages. The formation of terminology is due to social and scientific-technical development, since any new concept in a special field should be indicated by a term. Terminology is a collection of terms used in certain areas, it is a science that studies the terms, their properties, as well as the principles of their ordering and description. The terminological system appears when any field of knowledge or activity has developed sufficiently, has its own theory, has identified and realized all its basic concepts and the connections between them.

The terminological system is the result of conscious ordering or construction from natural, but specially selected units, which are full-fledged terms. According to V.M. Leichik, the terminology gradually develops together with the corresponding system of concepts and the corresponding field and acts as an unfinished system; According to the scientist, one can speak of a system of terms only when a system of concepts of the corresponding industry has developed. It is characterized by structuredness, integrity, coherence and relative stability.

The units of the terminological system should reflect their specificity, as well as the commonality of the terminology with other ones. As a conclusion, one should take into account that one should not put an equal sign between the concepts of "terminology" and "terminological system", since the term "terminology" refers to the ordering activity of a person in the framework of the nomination process, while the "terminological system" is associated with classifying human activity, aimed at sorting and identifying the relationship between the terms through the concepts they designate. "Terminology" is a spontaneously formed set of lexical units, while "terminological system" is a hierarchical system of terms ordered by terminologists.
