CHAPTER 1

DENTISTRY AND DENTAL ACTIVITIES

Dentistry is an independent branch of medicine that deals with the study of the causes and mechanisms of the development of diseases of the teeth, organs of the oral cavity, and the maxillofacial area. It also develops methods of their diagnosis, treatment and prevention.

Dental activity covers the professional work of specialists who have a certificate confirming their right to provide dental services, such as prevention, diagnosis, treatment and rehabilitation. This is possible with the informed consent of the patient or his legal representative, except in emergency situations. This also includes organizational, logistical and sanitary-anti-epidemic measures necessary to provide dental care.

Dental care includes a set of actions that comply with established protocols for the assessment, diagnosis, prevention and treatment of diseases of the oral cavity, maxillofacial region and adjacent areas. The purpose of these measures is to preserve and restore a person's dental health.

A dental service is defined as a set of measures performed by a dentist for the diagnosis, prevention and treatment (surgical or non-surgical) of diseases of the oral cavity, maxillofacial area and adjacent areas. It has a complete nature and a clearly defined cost.

A patient is any individual who seeks dental care (preventive, diagnostic, therapeutic or rehabilitation) or receives it, regardless of their health status at the time of application.

Legislative regulation of dental activities

Issues of dental activities in Ukraine are regulated by the provisions of the Law of Ukraine "Fundamentals of the Legislation of Ukraine on Health Care", the Law of Ukraine "On Dental Activities" and other regulatory documents and acts of professional self-government of dentists.
